Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before June 25, 2024 at 1:30p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on June 25, 2024 at 2:00p.m. onwards at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
