

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made this JUL 26 2024 day of _____ between the Provincial Government of Camarines Norte, Provincial Capitol, Daet, Camarines Norte (hereinafter called "the Entity") and R & E Builders and Supply, Vivencio St., Brgy. II, Daet, Camarines Norte (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute ITB-2024-042 - REHABILITATION & IMPROVEMENT OF MEDICAL & PEDIATRIC WARDS IN CNPH (PHASE I), CNPH, Daet, Camarines Norte (herein called "the Works") and the Entity has accepted the Bid for Four Million Two Hundred Fifty Four Thousand Nine Hundred Ninety Eight and 99/100 pesos only (P 4,254,998.99) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract; and
 - v. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs and of Annex G of the revised IRR of RA 9184. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after




the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Four Million Two Hundred Fifty Four Thousand Nine Hundred Ninety Eight and 99/100 pesos only (P 4,254,998.99)** or such other sums as may be ascertained, R & E Builders and Supply agrees to complete the **ITB-2024-042 - REHABILITATION & IMPROVEMENT OF MEDICAL & PEDIATRIC WARDS IN CNPH (PHASE I), CNPH, Daet, Camarines Norte** in accordance with his/her/its Bid.
4. The **Provincial Government of Camarines Norte** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
