

CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of _____, 2024 between **PROVINCIAL GOVERNMENT OF CAMARINES NORTE**, Provincial Capitol Daet, Camarines Norte of the Philippines (hereinafter called "the Entity") of the one part and **J & JK MEDICAL EQUIPMENT TRADING AND SERVICES** 924 SISA, Manila, Metro Manila, NCR, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **PR No. 24071897 - Supply and Delivery of Laboratory Supplies** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Nine Hundred Forty-Four Thousand Eight Hundred Forty Pesos only (P 944,840.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
3. In consideration for the sum of **Nine Hundred Forty-Four Thousand Eight Hundred Forty Pesos only (P 944,840.00)** (or such other sums as may be ascertained, **J & JK MEDICAL EQUIPMENT TRADING AND SERVICES** agrees to deliver **Laboratory Supplies** in accordance with his/her/its Bid.
4. The **PROVINCIAL GOVERNMENT OF CAMARINES NORTE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

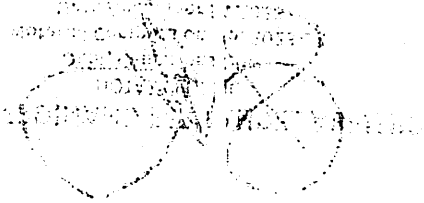
