A complete set of Bidding Documents may be acquired by interested bidders on July 16, 2025 August 7, 2025 at the Provincial Capitol Building, Daet, Camarines Norte and from the website of the Philippine Government Electronic Procurement System (PhilGEPS) upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on July 24, 2025 2:00p.m. at the Provincial Capitol Building, Daet, Camarines Norte, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before August 7, 2025 at 1:30p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on August 7, 2025 at 2:00p.m. onwards at Provincial Capitol Building, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, provided that an Authorization Letter shall be submitted to the BAC on or before the scheduled opening of bids. Only one (1) representative for each Bidder may physically attend the bid opening.
- 10. The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.
