Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
- In consideration for the sum of One Million Two Hundred Thirty-Three Thousand Nine Hundred Seventy-Two Pesos Only (P1,233,972.00) (or such other sums as may be ascertained, SOPHIE'S GENERAL MERCHANDISE agrees to deliver Medical Supplies in accordance with his/her/its Bid.
- 4. The PROVINCIAL GOVERNMENT OF CAMARINES NORTE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
