

CONTRACT AGREEMENT

MAY 15 2025

THIS AGREEMENT made this _____ day of _____, 2025 between **PROVINCIAL GOVERNMENT OF CAMARINES NORTE**, Provincial Capitol Daet, Camarines Norte of the Philippines (hereinafter called "the Entity") of the one part and **CRONIX PHARMA AND MEDICAL SUPPLIES TRADING** of 2410 Padillo Compound, PSA, Brgy. Gulang Gulang, Lucena City, Quezon, Region IV-A, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **PR No. 25010086 – Supply and Delivery of Medical Supplies** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Two Million Eight Hundred Thirty Thousand Five Hundred Pesos Only (P2,830,500.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
3. In consideration for the sum of **Two Million Eight Hundred Thirty Thousand Five Hundred Pesos Only (P2,830,500.00)** (or such other sums as may be ascertained, **CRONIX PHARMA AND MEDICAL SUPPLIES TRADING** agrees to **Medical Supplies** in accordance with his/her/its Bid.
4. The **PROVINCIAL GOVERNMENT OF CAMARINES NORTE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

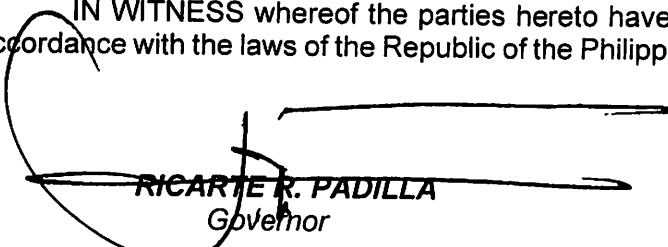

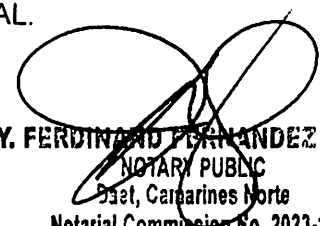
