THIS AGREEMENT made this _____ day of _____, 2025 between PROVINCIAL GOVERNMENT OF CAMARINES NORTE, Provincial Capitol, Daet, Camarines Norte of the Philippines (hereinafter called "the Entity") of the one part and POWERTRAC INCORPORATED of 2015C APOLONIA STREET MAPULANG LUPA, Valenzuela City, Metro Manila, NCR, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for PR No. 25041506 — Supply and Delivery of Three (3) unit Brand New 6-Wheeler 5 cubic Dump Truck Euro 2 (4x2) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum Five Million Ninety-Four Thousand Pesos Only (P5,094,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- 3. In consideration for the sum of Five Million Ninety-Four Thousand Pesos Only (P5,094,000.00) (or such other sums as may be ascertained, POWERTRAC INCORPORATED agrees to deliver Three (3) unit Brand New 6-Wheeler 5 cubic Dump Truck Euro 2 (4x2) in accordance with his/her/its Bid.
- 4. The PROVINCIAL GOVERNMENT OF CAMARINES NORTE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
