## Description

INVITATION TO BID for PR No. 25102745 - Supply and Delivery of Hardware Materials

- 1. The Provincial Government of Camarines Norte, through the PEO Repair and Maintenance Buildings and Other Structure AB2025 intends to apply the sum of One Million Five Hundred Thirty Thousand Three Hundred Seventy-Nine Pesos & Thirty-Six Centavos (P1,530,379.36) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 25102745 Supply and Delivery of Hardware Materials. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Provincial Government of Camarines Norte now invites bids for the Supply and Delivery of Hardware Materials (111 bag Portland Cement & 106 others) for Repair and Maintenance of Provincial Engineer's Office, Provincial Capitol Building, Daet, Camarines Norte.

Delivery of the Goods is required within 30 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent

(60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00p.m., Monday to Friday, except Holidays.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on October 21, 2025 November 11, 2025 at the Provincial Capitol Building, Daet, Camarines Norte and from the website of the Philippine Government Electronic Procurement System (PhilGEPS) upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on October 30, 2025 2:00p.m. at the Provincial Capitol Building, Daet, Camarines Norte, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before November 11, 2025 at 1:30p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on November 11, 2025 at 2:00p.m. onwards at the Provincial Capitol Building, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, provided that an Authorization Letter shall be submitted to the BAC on or before the scheduled opening of bids. Only one (1) representative for each Bidder may physically attend the bid opening.
- 10. The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.
