Description

INVITATION TO BID for the Construction of Box Culvert, Brgy. San Pascual, Basud, Camarines Norte

1. The Provincial Government of Camarines Norte, through the 20% Development Fund CY2026 intends to apply the sum of Nine Million Nine Hundred Ninety-Eight Thousand Nine Hundred Forty-Five Pesos and Sixty-Five Centavos (P9,998,945.65) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Box Culvert, Brgy. San Pascual, Basud, Camarines Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Camarines Norte now invites bids for the Construction of Site 1: 80.95m x 5m x 0.20m thk PCCP with 10m link slab & 2 barrel box culvert 4m span x 4m height x 7.60m width; Site 2: 80.10m x 5.00m x 0.20m thk PCCP with 10m link slab & 2 barrel box culvert 3m span x 3m height x 7.60m width. Completion of the Works is required 180 CD. Bidders should have completed, within 5 years from date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)."
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00p.m., Monday to Friday, except Holidays.
5. A complete set of Bidding Documents may be acquired by interested bidders on December 12, 2025 – January 6,

2026 at the Provincial Capitol Building, Daet, Camarines Norte and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on December 23, 2025 2:00p.m. at the Provincial Capitol Building, Daet, Camarines Norte, which shall be open to prospective bidders.

7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address below on or before January 6, 2026 at 1:30p.m. Late bids shall not be accepted.

8. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on January 6, 2026, 2:00 p.m. onwards at the Provincial Capitol Building, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, provided that an Authorization Letter shall be submitted to the BAC on or before the scheduled opening of bids. Only one (1) representative for each Bidder may physically attend the bid opening.

10. The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
