14.1	The bid prices shall be quoted in Philippine Peso.
14.3	Payment shall be made in Philippine Peso.
15.1	Bids will be valid for <i>120 days</i> from bid opening.
16.1	<p>The Bid Security shall be in the form of a Bid Securing Declaration, and choose at least two (2) from any of the following:</p> <ol style="list-style-type: none"> <li>1. The amount of not less than <i>2% of ABC</i>, if bid security is in cash.</li> <li>2. The amount of not less than <i>2% of ABC</i>, if bid security is in cashier's check.</li> <li>3.
