

CONTRACT AGREEMENT

CONTRACT FOR ITB-2026-024 CONSTRUCTION OF FARM TO MARKET ROAD Brgy. San Isidro, Talisay, Camarines Norte

This CONTRACT executed on the 26 day of MAR 26 2026 20____ by and between:

Provincial Government of Camarines Norte, a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

Century Glass Construction and Supply a company duly organized and existing under the laws of the Philippines, with principal office at Traders Road, Central Plaza Complex, Brgy. Lag-on, Daet, Camarines Norte, hereinafter called "the Contractor".

WHEREAS, the Entity invited Bids for certain goods and services/works/consulting services, particularly *Concreting of 110.00LM x 5.00m x 0.20m thk road with 0.50m shoulder on both sides; gravelling of 75.40LM x 6.00m and 4.00m width x 3.00m height x 6.90m length single barrel RCBC;*

WHEREAS, the Contractor submitted a responsive bid and was awarded the contract for the procurement in the total amount of *Three Million Nine Hundred Ninety One Thousand Six Hundred Two and 26/100 pesos only (P 3,991,602.26)*, hereinafter referred to as the "Contract Price."

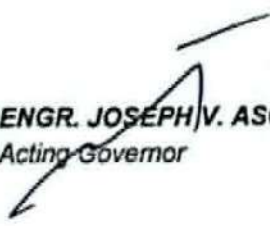
NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. Philippine Bidding Documents (PBD);
 - For Procurement of Infrastructure Projects
 - i. Drawings/Plans;
 - ii. Scope of Work;
 - iii. Invitation to Bid;
 - iv. Instructions to Bidders;
 - v. Bid Data Sheet;
 - vi. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - vii. Bill of Quantities;
 - viii. General and Special Conditions of Contract;
 - ix. Supplemental Bid Bulletins, if any; and
 - x. Other contract documents that may be required by existing laws and/or the Entity.
 - b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

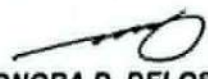
- c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **Three Million Nine Hundred Ninety One Thousand Six Hundred Two and 26/100 pesos only (P 3,991,602.26)**, or such other sums as may be determined in accordance with the terms of the Contract, the Contractor agrees to deliver and perform the items and related services for the **Construction of Farm to Market Road, Brgy. San Isidro, Talisay, Camarines Norte**, described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
4. The Provincial Government of Camarines Norte agrees to pay the above-mentioned sum to the Contractor in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
